- Since the attacks on 9/11, GTMO has operated as an alleged torture site for suspected terrorists
- Of the 40 current detainees, 26 are held without any charge filed against them

- 4. Create a public service announcement (PSA) with the eventual goal of a public apology.







## Legal Background


1. Article 1 of the Convention Against Torture

- the term "torture" means any act by which severe pain or suffering, whether physical or mental, is intentionally inflicted on a person...
- 2. Article 7 of the International **Covenant on Civil and Political** Rights
  - no one shall be subjected to torture or to cruel, inhuman or degrading treatment or punishment
- 3. North Carolina General
  - Statute Section 14-2.4 - a person who is convicted of a conspiracy to commit a felony is guilty of a felony that is one class lower than the felony he or she

conspired to commit

- Aero Contractors, Ltd. is a private charter company that was being used by the CIA to shuttle detainees from North Carolina to GTMO
- Aero was based in Johnston County, NC and was using public airspace
